

## General fee increase

The Q-COMP Board met on the 20 October 2009 and endorsed a Brisbane Health CPI increase for items covered under the:

1. Medical items schedule of fees
2. Supplementary schedule table of costs for specialist medical practitioners
3. Supplementary schedule table of costs for general practitioners.

## Fee CPI indexation

The ABS, Brisbane Health CPI figure from the June 2009 quarter was used to determine the CPI increase for medical fee payments. The Brisbane Health CPI rate which has been applied to fees from 1 November 2009 is 4.8%. All fees in the Medical items schedule of fees have been indexed according to the Brisbane Health CPI data with the exception of diagnostic imaging services which are currently under review.

## MBS changes

The medical items schedule of fees follows the same item numbers as the Medical Benefits Schedule (MBS), the following reflects the item changes that have been made in response to changes made by the MBS since 1 November 2008.
